I hereby enroll my child in the Temple Israel Early Childhood Center Gan Katan Program. Tuition must be paid in full by June 30, 2019, or in two equal payments on or before June 30, 2019 and October 30, 2019, as arranged with the Executive Director. I understand and agree to the following:

1. I understand that a \$50.00 **non-refundable/non-transferable application fee** must accompany this application.
2. I will submit **one check of \$250.00** made payable to Temple Israel with my application. **\$ 50.00** of the check is the **non-refundable/non-transferable application fee**. **\$200.00** of this check will be applied towards the **second** installment of tuition, if enrolled.
3. After submitting an application, if accepted, I will receive a letter of acceptance after our registration period has closed. I will have two weeks to return that acceptance letter signed in order to reserve my child's spot. Once the letter is signed, the \$200.00 deposit becomes non-refundable/non-transferable. If Temple Israel's ECC does not receive the signed letter of acceptance within two weeks, I understand that this will forfeit my child's spot and the \$200.00 will be returned.
4. I understand that the tuition schedule for the 2019-2020 school year will be established in the spring of 2019 by the Temple Board of Trustees, at which time I will sign the final enrollment contract.
5. I understand that if my child is admitted to Temple Israel Early Childhood Center Gan Katan Program due to priority as a member of the Temple, I must maintain my membership in good standing.
6. I understand that enrollment in the Gan Katan program does not guarantee enrollment the next year, as Temple members receive priority registration.
7. If there is a withdrawal of a child, by request of the school, tuition will be adjusted to the date of such withdrawal.
8. Temple Israel reserves the right to cancel any class without penalty due to insufficient enrollment. If a class is cancelled, the entire tuition and processing fee of \$50.00 will be refunded. If there is insufficient enrollment to offer two groups, the Jump Starts schedule will apply for all.
9. There will be no tuition refunds for any reasons, except as described above.
