I understand and agree to the following: Parents will be responsible for the total ECC tuition regardless of absences or withdrawal of the child from school for any reason. The entire ECC tuition is Non-refundable/Non-transferable.

I hereby enroll my child in the Temple Israel Early Childhood Center. Full year's tuition is payable in full or in two equal payments on or before April 30, 2020 and October 30, 2020 or as arranged with the Executive Director. I understand and agree to the following:

1. I will submit **one check** made payable to Temple Israel (**\$550.00**) with my application. **\$50.00** of the check is the **non-refundable/non-transferable application fee**. **\$500.00** of this check will be applied towards the **second** installment of tuition, if enrolled.
2. If I choose not to enroll my child or if my child is not accepted into the program by January 5, 201, **only the \$500.00 deposit will be refunded**.
3. I understand that after January 13, 2020, once I return a signed copy of the letter of acceptance to Temple Israel's Early Childhood Center, my entire deposit becomes non-refundable/non-transferable.
4. If I do not return the signed letter of acceptance by January 13, 2020 I understand my child's placement will be forfeited.
5. I understand that the tuition schedule for the 2020-2021 school year will be established in the spring of 2020 by the Temple Board of Trustees, at which time I will sign the final enrollment contract.
6. I understand that if my child is admitted to Temple Israel Early Childhood Center, due to priority registration as a member of the Temple, I must maintain my membership in good standing.
7. I understand that enrollment one year does not guarantee enrollment the next, as Temple members receive priority registration.
8. If there is a withdrawal of a child, by request of the school, tuition will be adjusted to the date of such withdrawal.
9. Temple Israel reserves the right to cancel any class without penalty due to insufficient enrollment. If a class is canceled, the entire tuition will be refunded.
10. Each child's immunization records must be in compliance with the State of Connecticut's guidelines and must be submitted by August 31, 2019.
11. There will be no tuition refunds for any reasons, except as described above.

2020-2021 Timeline and Checklist

Please read the following packet carefully before submitting your child's application.

As a membership organization, our fee schedule provides tuition discounts to members and the registration process grants priority to Temple members. In the event there are more applicants than available spaces, priority in placement and on the waitlist will be granted to Temple members in good standing.

In the Spring, after 2020-2021 tuition rates are established by the Temple Israel Board of Trustees, enrollment and payment contracts will be distributed to families. These signed contracts, along with your first tuition payment, will need to be returned by April 30, 2020. Please note, just as we do every year, we anticipate an increase in tuition.

Admissions Process for 2019:

- ✓ November 6-8 – Temple Member Registration priority
- ✓ November 13-15 Non-Member Registration opens
 - Applications must be handed in at Temple Israel's ECC office
 - Include a check for \$550 (\$50 deposit, \$500 tuition deposit)
- ✓ December 11 - Acceptance letters will be mailed out to families
- ✓ January 13 – Acceptance letters must be returned with a signature to reserve an enrollment spot. After January 14, spots will be opened up to the waitlist.
- ✓ April – Contracts will be distributed to parents. These will need to be signed and returned with your first tuition payment on or before April 30.
- ✓ August – Class lists will be emailed , along with necessary forms that will need to be completed and returned.
