I hereby enroll my child in the Temple Israel Early Childhood Center. Full year's tuition is payable in full or in two payments on or before April 30, 2021 and September 3, 2021. I understand and agree to the following:

- 1. I will submit **one payment of \$575.00** to Temple Israel with my application. **\$75.00** of the payment is the **non-refundable/non-transferable application fee**. **\$500.00** of this payment will be applied towards the **second** installment of tuition, if enrolled.
- 2. If I choose not to enroll my child or if my child is not accepted into the program by January 15, 2021 **only** the \$500.00 deposit will be refunded.
- 3. I understand that after January 15, 2021, once I return a signed copy of the letter of acceptance to Temple Israel's Early Childhood Center, my entire deposit becomes non-refundable/non-transferable.
- 4. If I do not return the signed letter of acceptance by January 15, 2021 I understand my child's placement will be forfeited.
- 5. I understand that the tuition schedule for the 2021-2022 school year will be established in the spring of 2021 by the Temple Israel Board of Trustees, at which time I will sign the final enrollment contract.
- 6. I understand that if my child is admitted to the Temple Israel Early Childhood Center due to priority registration as a member of the Temple, I must maintain my membership in good standing.
- 7. I understand that enrollment one year does not guarantee enrollment the next, as Temple Israel members receive priority registration.
- 8. If there is a withdrawal of a child by request of the school, tuition will be adjusted to the date of such withdrawal.
- 9. Temple Israel reserves the right to cancel any class without penalty due to insufficient enrollment. If such class is canceled, all fees will be refunded.
- 10. Each child's immunization records must be in compliance with the State of Connecticut guidelines and must be submitted by September 3, 2021.
- 11. There will be no tuition refunds for any reasons, except as described above.

2021-2022 Timeline and Checklist

Please read the following information carefully before submitting your child's application.

As a membership organization, our fee schedule provides tuition discounts to Temple Israel members and the registration process grants priority to Temple Israel members. In the event there are more applicants than available spaces, priority in placement and on the waitlist will be granted to Temple Israel members in good standing.

In the Spring, after 2021-2022 tuition rates are established by the Temple Israel Board of Trustees, enrollment and payment contracts will be distributed to families. These signed contracts, along with your first tuition payment, must be returned by April 30, 2021. Please note, just as we do every year, we anticipate an increase in tuition. The current year tuition is shown here for informational purposes only.

Admissions Process for 2021:

- ✓ **November 9-13** Temple Israel Member Priority Registration
- ✓ **November 16-20** Non-Member Registration opens
 - o All applications and deposits will be processed via an online link
 - o All applications must include a deposit of \$575.00
- ✓ **December 18** Acceptance letters will be mailed out to families
- ✓ **January 15** Acceptance letters must be returned with a signature to reserve an enrollment spot. After January 15, spots will be opened up to the waitlist
- ✓ **April** Contracts will be distributed to parents. These must be signed and returned with your first tuition payment on or before April 30
- ✓ **August** Class lists will be emailed, along with necessary forms to be completed and returned
- ✓ **September 3** Second tuition payment due
